Investec Australia Property Fund (ASX: IAP) – Admission and Commencement of Official Quotation – Deferred Settlement Trading

Description

Investec Australia Property Fund ('IAP') is expected to be admitted to the Official List of ASX Limited ('ASX') on Tuesday, 28 May 2019.
